## Topics discussed:

Certain portions of the roads are currently unsafe

What we are dealing with is a long term emergency

We have many people in this town with fixed incomes who cannot carry a heavier tax burden.

We looked at the "summary" from the April 30th meeting

In order to plan ahead for the town, we will need to better understand the work being done on the roads this year. Such as:

- -Timeline for the projects outlined for each road
- -Specs for each job
- -Order of priority (which might be obvious from the timeline)
- -Contractors and contracts

Exactly how many miles of road do we have in Stow? We think:

14 miles of town road

14 miles of state road (113 & 113B)

## Hauling gravel is expensive

We have a pile at the town garage that we can draw from in emergencies Moving gravel twice is more expensive, but maybe worth it for smaller needs For our bigger projects we can arrange for trucks to deliver their loads directly to the project

We discussed the Forest Service - and some of the history of White Mt. Nat'l Forest Stow "owns" 8 square miles of WMNF

Should the forest service be rebuilding that bridge?

We think they would rebuild it, but we would be obligated to pay them back.

What would happen if a lumber truck collapsed the bridge?

We think we, as the town of Stow, would be liable.

Do we have leverage? Can we "post" a bridge or a road?

Stow plow guy is Tray Morrison - he plows 13 miles of road

What is our multi-year contract with him?

We get subsidized from the state to plow state roads, but not enough to pay the bill

It used to be enough in the past

We are now having to take out loans to pay the expenses of the town

Plow insurance does not cover the cost of damaged/downed mailboxes

Towns often protect themselves with a bond for large amounts of work being done. TAR money - set aside \$20,000 a year drawing high interest What kind of contract do we have with Freddie Wilson? The importance of transparency

Portion of the current road budget for culverts & culvert repair: \$93,195
